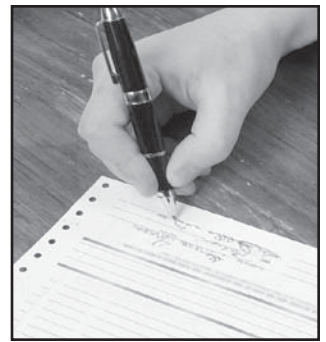

Operation Community Connect

The Aitkin County Homeless Coalition would like to announce the 2nd Annual Aitkin County Operation Community Connect has been scheduled for October 11, 2007 at the First Lutheran Church in Aitkin. Operation Community Connect (OCC) provides homeless and low-income people the opportunity to receive information and apply for services from a variety of providers all in one location on one day.

Last year, 161 families were served during the one-day event. Twenty-five different service agencies were represented including Aitkin County Health & Human Services, Aitkin County HRA, AADA, the Workforce Center, Lakes & Pines CAC, area public schools and senior organizations. Many volunteers were on hand to register participants, provide free daycare and provide a free lunch meal courtesy of the Salvation Army.

The main goal of OCC is to connect people to services that they may be unaware of or unable to obtain due to lack of transportation or



other extenuating circumstances. Services include free flu shots (provided vaccine is available), food shelf, Coats for Kids distribution and distribution of gas, grocery and phone cards. New to this year's event are mittens made by the tenants of MaryHill Manor and quilts sewn by the quilting club of First Lutheran Church.
